Rules for the allocation of the Hostel at IIMC, New Delhi (For Academic Year 2025-26)

All students are hereby informed that the allocation of hostel rooms for the upcoming academic session will be conducted as per the following rules and guidelines:

a) Eligibility & Reservation Criteria:

Merit-Based Process:

Hostel allotment will be based on academic performance.

- o For First Year students in case of MA courses, and for PG Diploma courses, selection will be based on CUCET Score / Entrance Exam Score.
- o For Second Year students, merit will be determined by marks obtained in the First Year.

Reservation Quotas:

As per Government of India norms, the following reservation will be applicable in each hostel:

- o EWS: 10%
- o SC: 15%
- o ST: 7.5%
- o OBC: 27%

Outstation Preference:

Hostel accommodation will be only for students from outside Delhi and the NCR region.

- Physically Handicapped (PH) Quota:
 - 02 seats in the Boys' Hostel and 03 seats in the Girls' Hostel are reserved for PH candidates.
 - Preference will be given to students with visual impairment and those with locomotor disabilities exceeding 40%.

b) Department-wise / Course-wise Quota:

"Department-wise quota for hostel allotment will be determined based on the percentage of students admitted in each department and the availability of accommodation in the respective hostels."

Formula for Calculation: Available Hostel Seats X Admitted Students in Course **Total Students Admitted in Campus**

c) Short listing:

Short listing of candidates will be carried out Course-wise based on merit and applicable reservation quotas. For this purpose, MA first year and MA second year shall be considered as separate courses.

d) Fee Payment & Finalization:

- Selected students must pay the hostel dues within the stipulated deadline to confirm their allotment.
- Late payment may lead to automatic cancellation of the allotted seat.

Important Note:

Supernumerary quota students shall not be eligible for hostel accommodation. They will also be excluded from all calculations related to seat allocation.
